7. Selection Criteria :- (80% weightage is on score of Educational Qualification and 20% weightage is on score of Interview)
 - a) Preliminary shortlisting of the candidate would be done on the basis of Requisite Qualification and shortlisted candidates will be called up for the personal interview and assessment.
 - b) The final selection of the candidate would be done on the basis of total scores obtained in the categories of Qualification and personal interview. Personal interview comprises of viva voice, competency test in the relevant field and computer proficiency (as per the Selection Panel).
